- Items not sold in 30 days will be discounted 20%. Items not sold in 45 days will be discounted an additional 30%; 60 days discounted to 50%. EXCEPTIONS: Holiday items will be discounted 50% as of the first business day following the given holiday. Handcrafted items will only be discounted no more than 20% with the exception of above holiday items. You may pick up consignment items as desired with 3-day notice to Mishmash & Muddle.
- **The consignment period** is for 90 days from above date. Items not sold in 90 days must be picked up within 7 days. Items not picked up within 7 days will be donated to a non-profit charity and a receipt will be provided for tax purposes.

**TERMS OF CONSIGNMENT AGREEMENT:**

\_\_\_\_\_ **OPTION 1:** Consignor will pay \$15 per month for rental space on a month-to-month basis and receive 75% commission on items sold. Rents are not pro-rated. Approximate size of rental space is 2 3/4' x 1 1/2'. Additional space is available for \$3 per month per foot.

\_\_\_\_\_ **OPTION 2:** Consignor will pay \$60 for a rental space of approximately 2 3/4' x 1 1/2' for six months and receive 70% commission on items sold. Rents are not pro-rated. Additional space is available for \$3.00 per month per foot. Entire rental fee must be paid at the beginning of contract date. No refunds for terminating contract early.

- Consignors paying a monthly rental fee will have their items returned to them after 90 days. If you prefer them to be donated to charity instead of returned to you, please initial here. \_\_\_\_\_ **AT THE END OF 90 DAYS, PLEASE DONATE MY UNSOLD ITEMS**

\_\_\_\_\_ **USED ITEMS:** Consignor will pay an annual \$15 Consignor Fee and receive 50% commission on items sold.

- Items not sold in 90 days will be donated to charity and a tax receipt will be sent to consignor.
- Upon examination, items not accepted for sale at Mishmash & Muddle will be donated to charity .
- Mishmash & Muddle is a community service charity. If a family is in need of consignor's essential-living items, such as clothing, my items (circle one) **may or may not** be given to the needy. Donations are tax-deductible and a receipt will be sent to consignor.

**ALL CONSIGNORS PLEASE USE:**

- Broken items will be discarded.
- From time to time, Mishmash & Muddle puts a group of items on sale, such as "All Lamps 25% off," or a customer will ask if the items may be discounted. *I understand my items may be discounted from time to time at the discretion of Mishmash & Muddle.*

**Payments** are made the 15th day of each month to consignors accruing a payment balance over \$50.00. Any balances under \$50.00 will be added to the next month's payment **OR** may be used as store credit. Payments will include an itemized sales report.

I understand that I will be sent the IRS Form 1099 when I earn over \$600 in a year (Jan—Dec).
